We are committed to protecting your personal information and being transparent about the information we hold. This privacy policy explains how and why we use your personal data so that you can be confident about giving us your information.

Who are we?

- We are GROWING TOGETHER CORNWALL CIC.
- We are registered as a community interest company, number: 12154347

What Personal Data do we collect?

- Your personal data (any information which identifies you, or which can be identified as relating to you personally for example, name, address, phone number, email address) will be collected and used by us. We'll only collect the personal data that we need.
Information you give us: When you make an enquiry by telephone or email, we will collect your personal data. This might include your name, email address and telephone number.
Under 18?
- If you are under 18, please ensure that you have the permission of the person with parental responsibility before you provide us with your personal data.

Why do we need your data?



- We need your basic personal data in order to be able to contact you about your GROWING TOGETHER CORNWALL CIC enquiry.

How will we use your personal data?

- We will use your personal data to allow us to respond to any questions that you have about GROWING TOGETHER CORNWALL CIC.
- All your personal data will be processed by staff within our organisation.
- We have a data protection policy in place to ensure the effective and secure processing of your personal data.

Will your personal data be shared with any third parties?

- GROWING TOGETHER CORNWALL CIC will not pass on your personal data to any third parties unless required to do so by the law or a regulatory authority.

How long will we store your personal data?

- Your personal data will be held for as long as it takes us to deal with your enquiry and no longer than is reasonable and necessary.

What are your rights?
